

# Monthly report for parish and community councils Mar 2017

## Full Council meeting

The Council met in March. There was little formal council business but there were four motions. I moved the fourth on the matter of 'sustainable high streets'. It was overwhelmingly supported. Go to <http://wp.me/p7tuu7-1sF> for my narrative of the day.

## Committee meetings and other council matters

General Purposes: there were several key decisions. One related to CREATE, an investment for a centre for Cambridgeshire Music in Cambridge, which was endorsed subject to a subsequent OK from the A&I Com (see below)

Adults: there were no key decisions. However it has agreed to proceed with its Neighbourhood Cares Pilot based on the Buurtzorg model of community care.

Health: there was one key decision relating to the award of the Stop Smoking contract. It was otherwise a mammoth meeting with scrutiny of the Cambridgeshire & Peterborough Clinical Commissioning Group's proposal to relocate the southern base for its Out of House service from Chesterton to Addenbrooke's, an agreed response to the same body's proposal regarding IVF and a review of the impacts of pollution on public health. Assets & Investments: there were no key decisions but it addressed the CREATE project which it agreed to support subject to confirmation that it would be the best use of this asset. It also updated the Council's policy regarding the siting of mobile phone masts on council property.

I joined meetings with three potential marketing partners for Cambridgeshire Housing & Investment Company. One is to be selected this month and it looks like it will be the one which I favour.

Economy & Environment: there were apparently no key decisions although I would have thought that the one relating to the Council's telecommunications strategy should have been one. It was endorsed but during the debate it was noted that the county's infrastructure is sub-standard and hardly compatible with its role as an 'economic driver' within the UK. I also noted that there were claims that it has been widely consulted upon despite evidence that this had been patchy. Another decision would have resulted in the withdrawal of funding for 'bikeability' cycling training for primary schools. I led a revolt against this and the proposal was withdrawn to allow alternative funding streams to be explored. Go to <http://wp.me/p7tuu7-1q3> for more on that story.

Children & Young People: there were no key decisions.

Highways & Community Infrastructure: there was one key decision relating to the Council's Resident Parking Policy. The Policy itself is just that, a policy, the devil is in its implementation and the Committee kicked that into the long grass until the City Deal has completed its deliberations on residents' parking schemes. We will need to watch that very carefully because the City Deal has a habit of ignoring King's Meadow and Orchard Park.

The City Deal Joint Executive Board met and agreed to the 'implementation of residents' parking schemes within Cambridge City' with a spend of £1million over the next 3 years. As noted above this needs to be watched carefully.

Planning: there were no items on the agenda relating to Cottenham, Histon & Impington. However note that the planning permission for the new pedestrian and cycle bridge across the Cam at Ditton Meadows granted last month is now the subject of judicial review.

The Cambridgeshire Police & Crime Panel met 15 Mar 17 but its decisions have not yet been reported. The Cambridgeshire & Peterborough Fire Authority did not meet.

The Cambridgeshire & Peterborough Combined Authority met for the first time (it's no longer 'shadow'). It was (yet) another largely procedural meeting.
